- 2. The Competition is open to individuals who are residents of New Zealand or residing in New Zealand at the time of the prize draw, including both North and South Islands and are 18 years or over. Any minors are to be accompanied by someone 18 years or over.
- 3. Submitted means registered as a Footprint customer and created your Footprint online Will through the Footprint platform and clicked the submitted button at the end of the Will which updates the status of your Will to be "Under review".
- 4. Footprint (the "Promoter") employees and their immediate families are ineligible to enter. The Promotor reserves the right to verify the validity of all entries.

## 5. Conditions of Entry

How to enter:
