

**Wills Month 2025 - Footprint FAQs:  
Win an Air New Zealand Mystery Breaks™ voucher for Two!**

**1. Who is eligible to enter the competition?**

Any individual who submits a Will through Footprint New Zealand between 1 September and 30 September 2025 is eligible to enter.

**2. How do I know if my Will has been ‘submitted’?**

You’ll know your Will has been submitted once you’ve completed all sections in the Footprint platform and clicked the **‘Submit’** button. Your Will status on your dashboard will then change to **‘Under Review’**, and you’ll automatically be entered into the draw.

**3. Can I enter more than once if I submit more than one Will?**

No. Only one entry is allowed per person, regardless of how many Wills you submit during September 2025.

**4. What if I’m still working on my Will — can I save and come back later?**

Absolutely! Just make sure to complete and **submit** your Will before **11:59pm on 30 September 2025** to be eligible.

**5. How will the winner be selected?**

The winner will be randomly drawn from the pool of eligible participants at the end of the campaign period.

**6. How will I know if I have won?**

We’ll notify the winner by email or phone within 1–2 business days of the draw. Keep an eye on our social media too - we’ll announce it there as well.

**7. What does the prize include?**

The prize package includes:

- Return seat+bag flights with Air New Zealand
- Luxury 5 star accommodation
- Daily breakfast and dinner
- Avis rental car for the full duration of your stay
- Car park at the accommodation provided

**8. What happens if I win but can’t travel?**

Only Wills submitted between 1–30 September 2025 are eligible. Wills submitted outside this period won't qualify for entry.

**12. Can I transfer the prize to someone else if I win?**

**13. Can I also qualify if I need a complex Will and do so through Perpetual Guardian?**
