- Information on how to enter the promotion forms part of the conditions of entry. Acceptance of the prize draw is deemed as acceptance of these terms and conditions.
- The competition is open to individuals who are residents of New Zealand, or who are residing in New Zealand at the time of the prize draw, including both North and South Islands, and are 18 years or over.
- 'Submitted' means you have registered as a Footprint customer either by paying for a Will service through Footprint or one of its partners, or by completing a free Will through a Footprint partner (available to all New Zealand residents), completed your online Will using the Footprint platform, and clicked the 'Submit' button, which changes the status of your Will to 'Under Review'.
- Employees of Footprint (the 'Promoter') and their immediate families are ineligible to enter. The Promoter reserves the right to verify the validity of all entries.

Conditions of Entry

How to enter:

To enter and be eligible to go into the draw to win, you must submit your Footprint online Will during the Entry Period ('Submitted Will'). Upon submission of your Footprint online Will, you receive one (1) entry into the draw ('Prize Draw'). Each completed and submitted Footprint Will is automatically entered into the Prize Draw, one entry per person.
